This year's trial will again be held on our grounds at the western end of the Field Day site. Our trials will commence on Tuesday 30th. with the Novice and Encourage classes. After Novice we will continue with the Improver/Open. We anticipate that Enc/Novice & Imp/Open will be combined. Details will be advised prior to commencement of trials. Provided there are sufficient entries and Sheep a Farm Dog Trial using 10-15 sheep and involving both field and yard work will be held. This will be run on Wednesday 1st. with a starting time determined by entries. Prize money as listed will be minimum and will be increased if sponsorship etc. permit.
