



## 2019 Dogpro Plus™ Finniss Trans Tasman Sheepdog Trial Saturday 27 to Sunday 28 April



To be held at the Finniss Oval.

All classes will be run on the  
Trans Tasman Course.

**The starting time will depend on  
the number of entries received and  
we may begin on Friday  
if required.**

### Encourage Event

The encourage trial is for competitors who have never won a higher, recognised trial. They may win two encourage classes before they must proceed to novice status and they may compete with dogs which have won trials at a higher level.

The encourage trial will be run on a simplified Trans Tasman course, and will not have a final. Entry fee is \$7 per dog and we offer prizes to third place.

### Novice Event

A final will be held for the novice class, consisting of the top four scoring dogs from the first round. Entry fee is \$7 per dog and we offer prizes to third place.

### Open/Improver Event

The Improver and Open classes will be held concurrently. Should a dog be entered in both classes, the score from their one run will count towards both classes.

A combined final will be held consisting of the top six scoring dogs entered in the Open class and the top four scoring dogs entered in the Improver class, from the first round. Should a dog qualify for both finals, they will have one run and their score will count towards both classes.

Entry fee is \$7 per dog for the Improver class and \$10 per dog for the Open class.
