PLEASE NOTE:

This trial is conducted under the rules of the SAWSDA, including the Code of Conduct as outlined in Sections 7 and 8 or their Constitution. A copy of this Code of Conduct is available from the SAWSDA Secretary, and will also be displayed at the Timekeeper's location at the trial.

The payment by a competitor for entry into this trial is an indication of their acceptance of the SAWSDA Rules and Constitution, including the Code of Conduct, which is applicable to all activities and areas of the venue location, and any specific regulations governing the use of the grounds and buildings associated with the trial.

Competitors entering the trial must be members of the South Australian Working Sheepdog Association or one of the other state affiliated bodies. If competitors are not members of SAWSDA, a \$20-00 public liability insurance levy needs to be added to your entry. This is a requirement of the Australian Working Sheepdog Association and their insurer.

Competitors please note: The course that will be used will be based on the Short Course trial with sectional judging. Depending on the space allocated to us, the course will be modified to suit the area.

Depending on entries, the draw may be worked twice, with the winner being the dog with the highest aggregate score. Competitors will be notified if it will be necessary to work the draw twice.
